- REFTEL STATEMENT CONVEYS USG CONCERN AT APRIL 14 RESOLUTION OF DANISH PARLIAMENT. IT NOTES USG DISTRESS OVER THE RESOLUTION'S IMPLICATIONS FOR NATO UNLTY AND COOPERATION. IT MAKES CLEAR THAT THIS IS NOT ONLY OR PRINCIPALLY A U.S. /DANISH ISSUE: BUT RATHER ONE THAT GOES TO THE HEART OF THE MEANING AND INTERLOCKING NATURE OF OUR MUTUAL COMMITMENTS WITHIN THE NATO ALLIANCE.
- IT IS IMPORTANT THAT PUBLIC STATEMENTS FROM OTHER ALLIES CONVEY THIS MESSAGE AS WELL. ALL ACTION ADDRESSES SHOULD IMMEDIATELY PROVIDE HOST GOVERNMENTS WITH COPIES OF THE USG STATEMENT. ALL ACTION ADDRESSEES EXCEPT ATHEMS
 SHOULD REQUEST THAT HOST GOVERNMENTS MAKE A SIMILAR
 STATEMENT. IF, IN EMBASSY'S JUDGMENT, IT WOULD BE
 INOPPORTUNE TO MAKE SUCH A REQUEST, EMBASSY SHOULD REPORT
 THAT FACT AND AWAIT FURTHER GUIDANCE.
- USNATO HAS INFORMED DEPARTMENT TELEPHONICALLY THAT AFTERNOON APRIL 15, NATO SYG CARRINGTON APPROVED THE FOLLOWING PUBLIC STATEMENT: "IF THE FOLKETING RESOLUTION WERE IMPLEMENTED IN SUCH A WAY THAT IT INTERFERED WITH THE LONGSTANDING COOPERATION AND INTERLOCKING DEFENSE INTERESTS OF THE ALLIANCE, THIS WOULD HAVE EXTREMELY SERIOUS CONSEQUENCES. WE SHALL THEREFORE BE WATCHING EVENTS WITH CONCERN. AND WILL BE MEETING FURTHER ON THE MATTER IN THE COMING WEEK. " SHULTZ
